### **Civics Report**

I would like to give everyone a heads up and provide some information regarding the rezoning bylaw that is currently in the works. The process seems somewhat similar to the Neighbourhood Renewal experience we just went through with the City. It takes years to finalize and from what I can gather, we are about a year before it reaches City Council to vote on the proposed draft. The aim is for October 2023.

From my understanding from a recent telephone conversation with the Edmonton Federation of Community Leagues, we are now at Stage 2. The City Administration is consulting with the Edmonton Federation of Community Leagues and hosting open houses for feedback. Please see the invitation for feedback later in the newsletter extended to everyone interested.

I also strongly encourage Grandview residents to share all comments and concerns with our councillor, Michael Janz. He is the one voting on this amendment. Please do not underestimate the desire to densify all neighbourhoods with various forms of developments.

What stood out personally for me was this paragraph from Page 3 of the 37-page summary of the bylaw:

"Building types proposed for this zone include: single detached housing, semi-detached housing, duplexes, backyard housing, secondary suites, row housing, small apartments and supportive housing."

I have asked the EFCL these questions and am waiting for all the answers in the near future:

- How easy is it to get an apartment or row house in a neighbourhood in a Small Scale Residential classification? Does a developer just need to fit it in prescribed measurements and it is automatic like the skinnies on subdivided lots now?
- Can neighbourhoods within the City be easily reclassified into the other city residential classifications (not including Rural Residential classification)? What is the procedure and considerations given in changing a neighbourhood's classification?
- Will variance notices still be sent out? If so, can they please be improved? Right now they are too vague and do not paint a picture of what will appear. Digital copies would be appreciated to avoid snail mail or other delays and allow more time to prepare for appeals to the City.
- Subdivision Development Appeal Board (SDAB) How will that improve or be affected? Now it is not a level playing field for communities and developers. Communities do not have money to pay for a lawyer each time a developer wants to do something wild in their community.

• I read Mature Neighbourhood Overlay will be retiring and added to the bylaw. Did all points get added or only a select few aspects protecting mature neighbourhoods?

I think we need to be proactive on this and work together in defining our neighbourhood in ways that we value most. Grandview Heights Community League is eager to coordinate efforts with you.

As invested stakeholders in The City Plan, we're reaching out to share a recent milestone. The Zoning Bylaw Renewal Initiative—the primary regulatory tool to implement The City Plan's vision—has recently shared the **draft Zoning Bylaw and "Know Your Zone" Rezoning Map on engaged.edmonton.ca/zoning bylaw renewal**.

Edmonton's Zoning Bylaw hasn't received a major overhaul in over 20 years and presents an opportunity to align our city-building tools, from strategy to regulation, to ensure all Edmontonians and property owners have the right tools to build and experience the city envisioned in <u>The City Plan</u>.

Now's your chance to dive into the:

- **Overview of the New Zoning Bylaw:** Read and share comments on the summary of the proposed zones and important sections of the new bylaw.
- **Draft Zoning Bylaw:** Take your time to read the entire bylaw or quickly reference areas of interest by using the interactive table of contents. Share your comments throughout the draft bylaw using the guided feedback tool.

We recognize the bylaw and initiative itself are technical in nature, so we've added a number of tools to help break down common zoning-related terms and concepts you may come across as you dive into the bylaw. Our <u>Engaged Edmonton</u> website offers links to videos, podcasts, a glossary of terms, frequently asked questions and more. Additional content will be added as it is developed.

We invite you to share your feedback online or in person now through December 18th, 2022. You can find a list of various engagement opportunities including workshops, open houses and pop-ups on Engaged Edmonton.
